

Rebirth Education and Research Foundation, NGO, with its Corporate Office at Visnagar (North Gujarat) was started with the sole motive to contribute towards late President of India, Dr. APJ Abdul Kalam's dream of making every Indian youth, especially rural youth, knowledge empowered through INDIA - VISION 2020. We are engaged in creating a vast pool of skilled professionals in the fields of IT, Healthcare, Apparel, Beauty & Wellness, Manufacturing and Retail sectors, through skill development and skill updation. These sectors have huge demand but very less supply of skilled manpower. Our motive is to provide these youth with meaningful placement nearby their home town.

The organization having ISO 9001-2015 certification is active in 85+ locations of Gujarat through its affiliates. We provide skill development training and employment/ self employment to socially, educationally and economically backward youth of the State. These trained youth are trained and certified by us with the help of various State and Central Ministries.

We are the market leaders in the skills training (IT, Soft Skills & Vocational Training) space in Gujarat and based on our past performance in skill development space we have been empaneled with various Central and States Ministries for skill development projects.

We are accreditated Training Provider of NSDC for PMKVY (Pradhanmantri Kaushlya Vikas Yojna) project (It covers 220+ job roles in more than 40 sectors). We are successfully implementing the project with the help of 5 PMKVY accreditated Training Centres.

We are empanelled Training Partner for Gujarat Urban Literacy Mission (GULM) with the Ministry of Urban Development, Government of Gujarat.





Since inception in the year 2009 we have trained more than 25000 students and have certified more than 21000 students. Apart from the education and training sector we are also engaged in other activities like women empowerment through training for establishing small scale units, providing free and subsidized medicine to poor and needy and providing legal help to females facing harassment. We are also utilizing CSR (corporate social responsibility) fund of large corporates for the benefit of the socially and economically backward people and fulfill the main aim of development of the society at large.

All our educational activities at various locations are managed through inhouse developed online portal for centre management. This portal manages all educational, training and placement activities of our organization including our 85+ business partners.

We have our own placement division that provides all placements related services under the aegis of www.rojgarseva.org. The major focus of this portal is to provide qualitative employment to the youth of Gujarat near to their home town. Our website provides training and placement guidance to undergraduates and other skilled unemployed youth, gives them required training in their work domain and places them in corporate sector according to their skills







#### **Wireman Training**

Under HDFC CSR we have provided training to 150 youth of 5 villages of Anand district who were class 10th pass and unemployed. After the successful completion of the training through HDFC Bank CSR around 70% of the youth got employment whereas 20% of them have become self employed and are financially independent.



#### **Digital Literacy Program**

As knowledge partner for HDFC Bank CSR for its CSR projects in Gujarat we have implemented two CSR projects in Digital Literacy and Skills Training. The CSR project under Digital Literacy is for the 9 villages in three talukas, of Gujarat, namely, Gandhinagar, Mansa and Dehgam where we have trained 9000+participants amd made them digitally lteterate. Now these participants are comfortable in using internet for various government schemes and even are comfortable in internet banking.



#### **Hand Rolled Agarbatti Making**

For HDFC CSR we have trained



For HDFC CSR we have trained and provided self employment to 300 females of 6 villages of Borsad taluka in Anand district for the job role of hand rolled Agarbatti making. 300 females of these villages are now financially independent and are successfully contributing in their household income.

ITC (Indian Tobacco Company) we have given skill training to 60 unemployed youth of Ahmedabad and Gandhinagar districts for the job role of distribution sales promotion and have provided them meaningful employment near their home place in malls and big shopping complexes.

Rebirth Education & Research Foundation became the first organisation in the Mehsana district to become the accreditated and affiliated with National Skill Development Corporation (NSDC) as a Training Partner for Pradhan Mantri Kaushal Vikas Yojna, Project sponsored by Ministry of Skill Development & Entrepreneurship, Government of India. Visnagar Centre has been affiliated with Electronics Sector Skill Council for the job role of Field Technician-Computing & Peripherals for PMKVY and Banking, Financial Services and insurance SSC for the job role of GST-AA. During the year we have trained 300 students with 80% placement.

Jay Somnath Pragati Mandal Trust, Kalol, managed by Rebirth Education and Research Foundation has been affiliated with Apparel & Handloom Sector Skill Council for the job role of Sewing Machine Operator and we have trained 60 participants with 85% placement.

Krishna Institute, Idar managed by Rebirth Education and Research Foundation is affiliated with Healthcare Sector Skill Council for the job role of Emergency Medical Technician and have trained 60 participants with 80% placement.

#### **Chocolate Making in Villages**


